SUBJECT: PUPIL/SCHOOL ACCOMMODATION REVIEW COMMITTEES – SIR JAMES DUNN PUBLIC SCHOOL & BLIND RIVER PUBLIC SCHOOL

1.1.0 Background

1.1.1 At the June 14, 2016 board meeting, Sir James Dunn Public School and Blind River Public School facilities were approved for “*Under Review Status*”.

1.2.0 Information

1.2.1 With the Trustees' approval of the identification of the above schools as “*Under Review Status*” the following excerpt from the Pupil\School Accommodation Review Policy 5.01 defines the next steps to be undertaken. The following is a brief summary of next steps:

1.2.1.1 *When the board, approves a motion, that identifies a school or schools as being “Under Review”, the following actions shall occur:*

1.2.1.2 *The Director of Education shall inform parents/guardians, staff, the school council(s), and the community(ies) of the identification and possible changes in accommodation status.*

The Director of Education shall specify clearly if school closure is an option.

1.2.1.3 *Prepare an initial staff report to explain the rationale for the pupil accommodation review process. See the Initial Staff Report, attachment B.1 #1 and B.1. #4 and the School Information Profile, attachment B.1. #2 and B.1. #5.*

1.2.1.4 *Make the Initial Staff Report and School Information Profile available to the public and have them posted on the Board's website.*

1.2.0 Information continued

1.2.1.5 The Board of Education shall appoint a local Accommodation Review Committee (ARC), in accordance with the Pupil Accommodation Review Guidelines (see attachments B.1 #3 and B.1 #6).

1.2.1.6 A minimum of thirty (30) days shall elapse between the date at which the Director of Education informs parents/guardians, staff, the school council(s), and the community(ies) of the identification and possible changes in accommodation status, and the local ARC's first public meeting. The date of this first meeting shall be established by the Board.

1.3.0 Recommendation

1.3.1 It is recommended that the Board approve standard accommodation reviews and approve the local Accommodation Review Committees for Sir James Dunn Public School and Blind River Public School (Attachment B.1 #3 and B.1. #6), with the first ARC meeting slated for late February, early March 2017.
