| NO REFUND                   | <b>NO</b> refund will be granted for tuition fees if: <ul style="list-style-type: none"><li>• The student withdraws thirty (30) days after the commencement of the program.</li><li>• The student is dismissed from the program due to a break of law, policy or regulation as determined by the Government of Canada, the Province of Ontario, the Police and or the Algoma District School Board.</li><li>• The student's immigration status changes during the term covered by the tuition fees paid except for students who become Permanent Residents of Canada. Those students will be eligible for a refund on a pro-rated basis.</li></ul> |
